## Invitation for Bids

Project Name: **Greater Mekong Subregion Border Areas Health Project (GMS-BAHP)**

1. The **Kingdom of Cambodia** has received a loan and grant from the **Asian Development Bank** toward the cost of **Greater Mekong Subregion Border Areas Health Project (GMS-BAHP)**, and it intends to apply part of the proceeds of this loan to payments under the Contract No. **GMS-BAHP CW-01: Renovation of Poipet Referral Hospital**.
2. The **Ministry of Health (MOH), Cambodia** through the **Project Management Unit (PMU)** now invites sealed bids from eligible and qualified bidders for the Renovation of:

**Poi Pet Referrals Hospital**

The construction period is **24 Calendar Months**.

3. Procurement will be conducted through National Competitive Bidding Procedures outlined in the Government's Standard Operating Procedures on Procurement for Externally Financed Projects/Programs.
4. This invitation is open to all qualified bidders from eligible source countries of as described in the Bidding Document.
5. Bidders attention is drawn to Sub-Clause 6.3 of the Instructions to Bidders (ITB) on the Qualification requirements. Qualification requirements include:
  - Average Annual Construction Turnover: The average annual volume of construction work of the successful bidder over the last **three years** (2022, 2023, and 2024) shall be at least **US\$ 13,330,000.00**.
  - Specific Similar Experience: The bidder shall submit evident confirming substantially or successfully completed experience as a prime contractor in the construction of at least **Two(2) similar contracts for works of nature and complexity equivalent to the Works** with contract value of not less than **US\$ 6,664,000.00** each within the last **five (5) years** prior to the bid submission date (from 1st January 2021 to 31st December 2025) (to comply with this requirement, works cited should be at least **70%** complete, billed and paid. The similarity of the works experience shall include: construction of hospital, poly clinics or health facilities, or medical buildings.
  - Liquid Assets: The minimum amount of liquid assets and/or credit facilities net of other contractual commitments of the successful Bidder shall be: **US\$ 1,111,000.00**.
  - For Cambodian Bidders: valid registration from the Ministry of Commerce (MOC), and Land Management Urban Planning and Construction (LMUPC), and a valid registration/permit /patent issued by the Ministry of Economy and Finance (MEF).
  - Bidders with duly audited financial statements by an independent firm, for the last **three (3) years** (2022, 2023, and 2024) demonstrating soundness of its financial position. As a minimum, the Bidder's net worth for the last **three (3) years** calculated as the difference between total assets and total liabilities should be positive. The financial statements and its audit should not violate the relevant national statutory accounting standards.
  - The qualification requirements are more completely described in the Bidding Documents.
